

Enhanced Assisted Living Residences (EALR)

An Enhanced Assisted Living Residence (EALR) is an Assisted Living Residence that has an additional certification from the New York State Department of Health that permits assisted living residents to "age in place." Residents receive a substantially higher level of care than provided in traditional assisted living, bridging the gap between assisted living and a skilled nursing facility. Services may include diabetic management, physical assistance with ambulation and transfers, incontinence management and assistance with other complex medical issues and equipment. Each facility may be licensed to care for specific conditions and needs. Discuss individual needs with the facility.
