

## **PRI (Patient Review Instrument) Providers**

A PRI (Patient Review Instrument) and screen is a professional assessment and screening of all skilled nursing facility applicants. It is used as a "benchmark" or universal assessment to determine appropriate level of care. The assessment results in a "score" that corresponds with various levels of care and assures appropriate services to meet the resident's needs. A PRI is required by the New York State Health Department before admission to a skilled nursing facility. (PRI charges vary, generally from \$100-\$325)
